C-RS Complies with Anti-Spam Regulations Courtesy of Tom Brenzovich

Regulations exist in both the United States and Canada to regulate commercial email messaging and limit unsolicited messages commonly called "spam". Penalties for non-compliance are significant in both cases. The C-RS does not participate in the delivery of spam type emails, only emails that are relative to the C-RS and its activities. These regulations – and how the C-RS Membership Site in conjunction with the Wild Apricot software can comply with them – are discussed below.

To help comply with regulations that require express consent before sending an email to a member/ contact, the C-RS Memberships Site now provides an opt-in mechanism so that members/contacts can expressly provide their consent to receive emails from the C-RS.

Opting in means the members/contacts have given their consent to receive emails from the C-RS. They can still pick and choose the kind of messages they want to receive.

Opting out means the members/contacts have specifically denied their consent to receive emails from the C-RS. They will still receive confirmation emails in response to specific actions on their part, such as membership renewal notices or event registration/attendance confirmations, but they will not receive event announcements and other email blasts.

The CAN-SPAM Act of 2003 provides standards for sending commercial e-mail within the United States, and is enforced by the Federal Trade Commission (FTC). Each separate email in violation of the CAN-SPAM Act is subject to penalties of up to \$16,000.

The Canadian Anti-Spam Law (CASL) applies to any organization that sends commercial electronic messages to recipients based in Canada. Penalties for non-compliance come into force on July 1, 2017. The maximum penalty for violations is \$1 million for individuals and \$10 million for businesses.

A commercial electronic message is an email containing commercial or promotional information including marketing, sales, offers, solicitations, or similar messages. The C-RS does not participate in these types of email; only emails such as announcements (email blast), sponsored events, event registration/ attendance confirmation, membership renewals/reminders and the C-RS Connection newsletter.

Before sending a commercial electronic message to a Canadian resident, you must obtain consent. You should also be able to prove how and when that consent was given should the need arise. There are two kinds of consent: express and implied.

Implied consent

- If you are a club, association or voluntary organization and the recipient is one of your members, you • have implied consent, as long as the individual remains a member
- If someone submits an application, registers for an event, donates or subscribes to receive emails ٠ through your site then consent to receive emails from you is implied.
- However, this implied consent is valid for 24 months from the transaction date, after which you will need to obtain express consent.

Express consent

- Obtaining express consent requires a user to take a pro-active step to consent to receiving emails • from you. It is our understanding that simply agreeing to your "terms of use" for example is not enough – they need to actually agree to receive emails from you.
 - Your request for consent must clearly include:
 - Concise description of your purpose in obtaining consent
 - Description of messages you plan to send
 - Your name and contact information (Mailing address and either phone, email or URL)
 - A statement indicating they are free to unsubscribe at any time.

Wednesday, June 21, Fort Mill, SC




Saturday, July 15, Center Valley, PA
